Weekly rates per apartment

ARRIVALS AND DEPARTURES: every day until 26/06 and after 04/09, Tuesday from 26/06 to 04/09, other days on request; check in from 16:00 to 22:00; check out before 10:00;

MINIMUM STAY: 3 nights until 26/06 and after 04/09, 7 nights from 26/6 to 04/9, shorter stays, only on request, 20% surcharge;

BOOK IN ADVANCE: up to 20% reduction until 30/04, 10% reduction until 31/05.

BILO 2 SPECIAL: reduction of 10% compared to the BILO rate, in BILO 2 it is possible to add the baby cot.

TRILO SUPERIOR: 15% surcharge on the TRILO rate.

FORFAIT FOR LAUNDRY AND BILLS: € 25 per day per apartment to be paid locally.

FINAL CLEANING: € 70 per apartment to be paid locally; excluding waste disposal and cleaning of the kitchenette / oven / fridge, that has to be paid by the guest, or against payment of 25 euros

DEPOSIT: € 100 per apartment, returnable at the end of stay

OPTIONAL COSTS ON SITE:

- Baby cot € 35.00 per week
- Daily housekeeping, excluding kitchenette, € 15.00
- Change of bed linen and towels € 15.00 per apartment
- Kitchen linen not supplied
- Washing machine: € 10 to wash with detergents provided on site
- Late check-in after 22:00: € 20.00, on request

ANIMALI DOMESTICI: Small animals (up to 20 kg) are allowed, with restrictions in common areas and mandatory contribution of expenses for final cleaning.

Tourist tax: Italian municipalities have the right to apply the residence tax. This fee is not provided in the rates shown in the table. If applied, it must be paid directly at the hotel.
